

Meeting held at 8, Beechey's Avenue 10th February 1960

The minutes were read & signed.

The chairman read Mr. Gammon's letter of resignation from the position of Secretary. It was agreed to write to Mr. Gammon to express regret at his decision, to thank him for his good work in the past and to hope that he would be willing to continue to serve on the Committee.

It was resolved to write to the Clerk to the Parish Council to try to forward the matter of the lease of the Village Hall site.

Concern was expressed on the possible effects of the proposed new road on the site of the Village Hall, and the Secretary undertook to try to obtain further information.

It was decided to hold a number of Social Evenings/Bingo. The first two to be on 3rd + 17th March and bookings were to be made for these two.

It was decided to hold a Public meeting to

The Secretary reported on the draft lease & it was decided to urge a longer term than the 28 years suggested.
