Minutes of a Public Meeting held in St. Nicholas Primary School
on 21st March at 8.0 p.m.

The Chairman opened the meeting and after explaining its purpose he went on to report the death of the Building Fund Treasurer Mr. Haynes and asked that a letter of sympathy from the meeting be sent to Mrs. Haynes.

Secretary's Report on the work of the retiring committee. When the committee took over the fortunes of the Village Hall project were at a very low ebb. After several abortive attempts to get the hall built many had lost heart.

Although some plans were in existence it was decided to start afresh and an architect was commissioned to draw up new plans in the light of present needs.

The committee were very pleased with the design and it received the praise and approval of the N.C.S.S. and the Ministry of Education's architectural panel.

A lease of the site was negotiated with the Parish Council and thanks were expressed for their co-operation, and help.

An application for a grant was made and a provisional offer received from the Ministry of Education.

The Secretary then reported on the money-raising events which had been held, and thanks were expressed for the Movement Association help in allowing the Village Hall Committee

to participate in the Gala Day.

It was reported that the fund stood at a little under £2700 which was about $\frac{1}{3}$ rd of the total of £8,080, the estimated cost of the Hall and equipment, including £200 for materials for external work.

The Ministry grants would meet an additional third, and the Parish Council had been asked to raise a loan to provide the last third.

The hope was expressed that a start might be made on the Hall in June.

from its own stalls.

It was decided to erect a 5' chain link fence with 7' concrete posts
around the Village Hall site as soon as possible after the completion
of the lease, and the secretary was asked to write to the
Clerk to the Parish Council to assure the council that an alternative
access to the Recreation Ground would be provided to replace the
present one.

An equipment sub-committee consisting of Mr. Johnson, Mr. Tasker +
Mrs. Horsington was appointed to review the list of equipment
+ to obtain prices of items required

was asked to attend the Allotment Association meeting to

Tenders: Details of the three tenders for the erection
of the Village Hall together with the architects recommended
were given by the Secretary. After some discussion it
was proposed by Mrs Horsington a seconded by Mr. John
that the tender from Basil Wyatt be accepted. This was
passed unanimously. It was then proposed by Mr. Jones
& seconded by Mr. Horsington that the Committee ask Mr.
Wyatt for a bond of ~~£~~ a suitable sum. ^{Passed unanimously} It was
proposed by Mr. Jones & seconded by Mr. Earl that we
ask the builder to commence work as soon as possible
this was passed unanimously. It was also agreed that
the Archdeacon be authorised to place orders for the
bricks and structural laminated timber. It was
proposed by Mrs. Yates & seconded by Mrs Constable
that a further payment of £180 for professional
services be paid to Messrs Walter Price the Architects.

Passed unanimously. It was decided to proceed with the erection of a fence to the site as soon after the Gala Day as possible, and the Secretary undertook to order the materials.

Apologies for absence were received from Mrs. Constable + Mrs. Harvey

It was reported that Mr. Wyatt had been unable to ^{+ Mrs. Yates}
raise a bond as had been previously resolved. The Committee
decided therefore to proceed without the bond. Proposed Mr. Horsington
^{+ seconded by Mr. Earl}

It was decided to purchase 150 beech plants to form
a hedge to the site of the Hall.

It was proposed by Mr. Horsington + seconded by Mr. Earl
that steps should be taken to transfer the hall to
the Public Trustee as soon as possible - Passed unanimously.

It was resolved that a sign board should be made
for the Village Hall site, to be black on white.

It was resolved that the Parish Council be asked to

take up on behalf of the Committee the amount of the loan previously agreed by them & approved by the Parish Meeting.

The Secretary reported on various variations to the contract which had become necessary & after some discussion these were approved including "Springlok" patent semi-sprung flooring for the Hall at a cost of approximately £315.
