In Mr. Rumbold's absence Mr. Tasker was appointed chairman

The minutes were read and signed

The Secretary's report showed that the Hall had had  
a successful year. The provisional accounts to the end  
of March showed a healthy position. The Nursery Group  
had had a satisfactory year with a useful balance off  
all expenses had been net. The usage of the Hall  
by the Y.H.A. during July & August had resulted in an  
income of £28. Lettings for Wedding & private functions  
had been quite numerous & brought in a good income.  
Work by a small band of volunteers on the forecourt  
of the Hall had proceeded slowly but steadily &  
the major work was now nearing completion.

The secretary reported that he had received a request  
for the payment of the final £100 which it had  
provisionally agreed to pay to the Builder Mr Wyatt  
and that he had received a further and unexpected

account from the architect. It was decided to defer payment on the first item until such time as the committee were convinced that the flooring in the Hall was not likely to give further trouble. The secretary was asked to obtain further information on the second item and if necessary to ask the architect to meet the committee.

The committee decided to write off a debt of £2-10-0 owed by the Youth Club for a letting for a dance.

Permission to run dances by a sub-committee consisting of Mr. Roy Jones, Mrs Keith Hornington, Mr. David Hammond + Mr. David Woodward was agreed and the treasurer was asked to provide them with a £10 float.

It was agreed that again this year the Over 60's club could use the Hall free of charge for their annual party and that the Hall committee would contribute £5 to the cost of the food.

It was decided that meetings of the Committee should be held at intervals of 5 weeks on Wednesday evenings at 7.30 p.m.

It was decided that the treasurer should be provided with some professional help in the preparation and presentation of the accounts.

that a sum of £5 be paid to the Nursery Group

meeting of the committee.

It was proposed by Mrs Costable + seconded by Mr. Jones  
that the stage be provided with a box curtain set.
