

Minutes of a meeting held in the Hall on Tuesday 26th January 1965 at 8.0 p.m.

The minutes of the previous meeting were not read as the minute book was with the auditor.

A letter of resignation was received from Mr. Johnson, who is leaving Old Marston. The committee expressed its thanks to Mr. Johnson for all that he had done for the Hall. It was decided to take up a collection among Committee members at the next meeting in order to make him a small presentation.

The Secretary reported on the somewhat unsatisfactory standard of cleaning in the Hall of late. After some discussion it was decided to give Mr. Horsington another month's trial to see if things could be improved. It was decided that certain work, which needed to be carried out ~~should~~ would have to be done pro tempore (Repairs to tables + stage front) Other work such as redecorating should be carried out by Committee members if possible.

The Annual General Meeting was provisionally arranged for March 2nd.

The Treasurer reported that no refund had been received from the Architects of the over payment on their account of £30. The Secretary was asked to write to them about it.

It was decided that the Village Hall Committee should collaborate with the Committee of the Boys' Club to arrange a Summer fête, and a Sub-Committee of Mrs Harrington, Mr. Humbold and Mr. Jones was appointed to deal with this.

The setting up of a fund for the building of an extension to the Hall was discussed & it was decided that the Secretary should meet with Mr. Howard to arrange a draft agreement on this.

Mrs Sheppard raised the question of fencing for the site of the Hall & it was decided that if the permanent ~~bunding~~ walls were not ready by the Spring that a temporary fence of chestnut palisade should be put up so that the children of the Nursery Group could use the ground outside the Hall in fine weather.

Minutes of First Annual Meeting 23rd June 1966

After the Chairman had welcomed those members of the public who were present, the Secretary presented a report and financial statement for the past year. He reported on the work done on the hall the cost of which was £7,819 to date. A good deal of work still remained to be carried out outside the hall. This had progressed slowly due to the lack of help. He reported that the Committee of the Boys' Club would like to see an extension built on to the hall in the form of an indoor games room or gymnasium and some changing facilities. The Village Hall Committee had decided that any extension should also include a store room.

The Secretary gave an account of the use made of the Hall. Private lettings had raised £270. In addition to the regular use of the Hall by village organisations it had been let to the Youth Hostels Association during some of July and August as a temporary hostel. The Hall Committee had tried to organise social activities for adults but these had met with little success and had to be abandoned.

On the other hand the use of the Hall by young people from the Nursery Group to the Youth Club had been very satisfactory + fully justified the building of the Hall. It had been decided not to hold a Gala Day for 1964 but some other smaller money raising activities were planned. The Secretary then commented on the auditors report and accounts. Although the Hall was paying its way there was very little left over to pay for renewals of equipment and this was depreciating at an alarmingly fast rate.

The Secretary reported that some damage was being done to the hall by the Boys Club + that it was not always left in a very clean state after their meetings, this applied particularly to the toilets. It was resolved to reconsider the scale of charges at the next meeting.

The proposed terms for the setting up of a building fund were presented. These were accepted nem-a (Proposed Mr. Earl, seconded Mr. Rumbold). Mr. Haynes was appointed trustee on behalf of the Village Hall.

Committee. It was reported that the fete had been arranged for Sept. 4th and a list of stalls which it was suggested that the Village Hall Committee should man was presented. Certain members indicated their willingness to assist on these stalls.

The Minutes were read + signed

The Secretary reported that the use of the Hall by  
the Boys Club was still not satisfactory. Damage was  
still being caused, which did not appear to be due  
to fair wear + tear, also the cleanliness of the  
Hall + particularly of the toilets after occupation by  
the Boys Club was sometimes unsatisfactory. The

Secretary was asked to write to Mr. Howard about this

The Secretary reported on the work that had been done  
during the past months on the forecourt or the terrace  
by voluntary labour. A vote of thanks to Mr. Earl  
was passed in gratitude for the climbing rose which  
he presented + planted in front of the Hall. The  
Secretary also reported on the repair + renewal work  
which had been carried out inside the hall, the  
most important item being the relaying of the  
floors in the Library + Committee Room.

The Treasurer reported on the financial position. In spite  
of heavy expenditure on the repairs + renewals the

bank balance showed a healthy position. Income from lettings was satisfactory.

Arrangements for the summer fete were discussed + it was decided that the Village Hall Committee would man most of the stalls, which had been suggested by the Boy's Club Committee but that some additional help would be required.

The Committee considered the scale of charges for the letting of the Hall + decided to make no alterations.

It was proposed by Mr. Jones + seconded by Mrs Horsington that as in previous years the Over 60's club should be given the free use of the hall for their Christmas party + that in addition the Village Hall Committee would pay for the ham from Hall funds.

It was proposed by Mr. Hayes + seconded by Mrs Turner that the following honoraria be paid: Secretary £20  
Treasurer £10.
